After nearly thirty years of independent governance, Croatia has endeavored to develop a solid infrastructure to support its civil society. A culture that has been shaped by conflict and violence now looks to a bright future. Supported by U.S. and international nongovernmental organizations, Croatia is home to some of the most innovative programs in Europe, addressing the challenges of access to health care, advancing education, stabilizing the rule of law, and ensuring basic human needs for their entire population.



#### LEADER BIOGRAPHIES

**Richard Pena** is an attorney in Austin, Texas, and is the founder and CEO of the Law Offices of Richard Pena, P.C. He has served as both President of the American Bar Foundation (2009-2011) and President of the State Bar of Texas (1998-1999). Additionally, he served on the Board of Governors of the American Bar Association in 2007-2010. He is rated "AV" by the Martindale-Hubbell Law Directory, indicating a "very high to preeminent" reputation for legal ability and a "very high" general recommendation.

Richard graduated with Bachelor of Arts and Doctor of Jurisprudence degrees from the University of Texas, where the law school faculty awarded him an honorary membership in the Order of the Coif. He is recognized as a national leader in the legal field and received the Distinguished Lawyer Award presented by the Austin Bar Association in 2007. The Texas Bar Journal has recognized him as one of 20 "Trailblazers" in their February 2014 issue, and in 2010 he received the Difference Makers Award presented by the ABA General Practice, Solo & Small Firm Division.

Richard has led approximately 18 delegations of Texas and U.S. lawyers abroad to interact with leading lawyers, judges, professors, and political figures of various countries. He has been Chair of the Leader Advisory Board for the People to People Ambassador Program, and received the Eisenhower Achievement Award from People to People Ambassador Program for being an outstanding delegation leader.

Richard is a Vietnam veteran and left on the last day of American military involvement in Vietnam in March 1973. #### **BRIEF ITINERARY**

Day 1

**Departures from the US to Zagreb**, Croatia by individual arrangements. Delegates arrive throughout the day. Evening Introductory program briefing.

Day 2

**Full day cultural tour of Zagreb** and its surrounding areas: Zagreb sightseeing and visit to Krapina Zagorje County.


Day 3

Introduction to the Croatian Legal System by the **Ministry** of Justice (MOJ), to discuss the role of the Ministry of Justice, the Parliament and the European Union in sculpting the legal system. Meeting with the Croatian Bar Association to lean about practicing law in Croatia, human rights and immigration issues. Afternoon visit to a local market to experience the richness of Croatian culture.

Day 4

Meeting with faculty and students at the **University** of **Zagreb** to discuss the structure of legal education, access, and funding. Afternoon panel discussion with law students.

Day 6

Wrap-up meetings with local **MOJ** and **Bar** Association leaders to discuss observations and developments for the future. Visit a local court in Rijeka Region or Ičići to learn about the legal system outside of Zagreb. Discuss the independence of the judiciary due process. Afternoon cultural visits in the rural communities and visit a handicraft market. End with a farewell celebration dinner.

Day 7

**Depart for the United States** or program extension tour.

The program will be finalized based on the guidance of the delegation leader, the interests and composition of the group, and the scheduling needs of hosting resources in country.

Prospective participants must apply and be approved by the delegation leader before proceeding with registration. A \$500 nonrefundable deposit is due upon approval of your application. The balance is due upon receipt of invoice, 90 days before departure.

Program fees are based on double rooms. A single-room supplement is provided as an option. If you have to cancel, you must submit your request in writing, dated upon receipt.
